Order

- 1. The petitioners have approached this Court with the grievance that though they had secured more marks and stood higher in merit list in the result declared by the respondent no.2 Senior Director (Exams), NEET (PG)-2024, the respondent no.3 Chairman, NEET PG Admission/Counselling Board (hereinafter referred to as 'the Counselling Board') is going to give admission in PG Courses run by the institutions in Rajasthan to the candidates, who secured lesser marks than them and were lower in merit.
- 2. Mr. Kailash Jangid, learned counsel for the petitioners invited Court's attention towards the table given in Para No.14 of the memo of petition; the Provisional State Merit List (Combined) PG Medical Candidates issued on 22.11.2024 and other documents placed on record and highlighted that due to some technical or





procedural error, the list of the candidates given admission in PG Course is erroneous.

- 3. Learned counsel further submitted that similar type of error has been committed by various States' Counselling Board and on 22.11.2024, the High Court Madhya Pradesh has passed an interim order in a case titled as **Dr. Abhishek Shukla & Ors. vs.**The State of Madhya Pradesh & Ors. (W.P. No. 37078/2024).
- 4. This Court has verified the facts stated in table given in Para No.14 of the memo of petition and has prima-facie found substance in what the petitioners have contended.
- 5. Mr. N.S. Rajpurohit, learned Additional Advocate General has not been able to controvert the fact-situation as narrated in the memo of petition and elucidated by Mr. Jangid, learned counsel for the petitioners.
- 6. Having heard the learned counsel for the parties and upon going through the record, this Court is of the prima-facie view that some error has crept in, maybe because the respondents have taken raw marks secured by the candidates in the examination conducted by the respondent no.2 instead of taking normalized marks or otherwise.
- 7. Mr. Mukesh Rajpurohit, learned Dy. Solicitor General and Mr. N.S. Rajpurohit, learned Additional Advocate General pray for and are granted seven days' time to complete their instructions.
- 8. List this case on 05.12.2024, as prayed.
- 9. Till then, the respondent no.3 Counselling Board shall not finalize the list of candidates to be admitted in NEET (PG) Course-2024 of State's quota. It shall, however, be free to find out the





error and prepare fresh list for consideration of the Court, of course after addressing the concern expressed by the petitioners.
